COVID-19 SAFETY INFORMATION: The 2019-2020 outbreak of the novel coronavirus (COVID-19) has been declared a worldwide pandemic by the World Health Organization. **COVID-19 is extremely contagious** and is believed to spread mainly from person-to-person contact. In regards to offering our Services, including any Events & Activities related to our Services, Balanced You™ (hereinafter "the Company") has put in place preventative measures to reduce the spread of COVID-19; however, we cannot guarantee that participants, volunteers, partners, or others in attendance will not become infected with COVID-19. - Neither you, nor any household members, have knowingly been exposed to anyone diagnosed with COVID-19 within the past 30 days;
- Neither you, nor any household members have traveled outside of the country or to any city considered to be a "hot spot" for COVID-19 infections within the past 30 days;
- You understand that Balanced You™ cannot be held liable for any exposure to the COVID-19 virus caused by misinformation on this form or the failure by any other client or participant to be truthful in their representations or to limit their individual exposure.

You agree to *immediately notify* the Company if your circumstances change in regards to any of these representations and to cancel your attendance at the event in order to minimize the risk of spread of COVID-19.

Because COVID-19 is extremely contagious and is spread mainly from person-to-person contact, the Company is following these enhanced procedures to help prevent the spread of COVID-19:

 Air filters will be running in the retreat suite. Social distancing is recommended. Masks are available. Hand sanitizer is available. Attendees may elect to have remote instead of live muscle testing. Participants are reminded and encouraged to be mindful of their travel arrangements and accommodations, to limit their exposure while traveling to and from, and while attending the event or activities.

- 4. - 5. That if you are injured, you agree to assume any financial obligation related to such injury, either through your personal health insurance or other means, including for any medical costs which you incur.
